

COLORADO RIVER MUNICIPAL WATER DISTRICT
POLICY ESTABLISHING RULES GOVERNING
BASS TOURNAMENTS
and
FOOD AND PRODUCT VENDORS
WITHIN DISTRICT RECREATION PARKS

Section I

FOR PROFIT BASS TOURNAMENTS

- A. A permit shall be required of tournament sponsor if the number of entries is greater than 500. Sponsor shall apply for the permit no later than 60 days prior to the scheduled tournament date. Permit application shall be made to:

- B. A fee of \$100.00 per day shall be assessed.

Section II

NON-PROFIT BASS TOURNAMENTS

- A. No permit is required if the number of entries is less than 500. For tournaments with greater than 500 entries, a permit shall be required. There shall be no fee for non-profit tournaments. Sponsor shall apply for the permit no later than 60 days prior to the scheduled tournament date. Permit application shall be made to addressee in paragraph Sec. I, A above.

Section III

FOOD and PRODUCT VENDORS

- A. Food and product vendors shall not be permitted without expressed authorization by the District. Bass tournaments with less than 500 entries, outside food and product vendors shall not be authorized. For bass tournaments with greater than 500 entries, the District will consider authorizing outside food and product vendors if the concessionaire agrees.
- B. The tournament sponsor shall not assess fees for outside food and product vendors.
- C. Food and product vendors shall be required to have a permit.
- D. Vendors shall apply for the permit no later than 30 days prior to the scheduled tournament date. Permit application shall be made to:

- E. A fee of \$25.00 per day shall be assessed for outside food and product vendors.
